- Can observe children for the purpose of creating learning opportunities that promote development within social, emotional, cognitive, language, sensory and physical domains.
- Has experience working within school age or camp programs and can support every function within the program; this includes outdoor activities, classrooms, cleaning, and administrative tasks.
- Has experience working with children ages 6 to 12 and their families.

- Creating warm, welcoming interactions that protect the health, security and well-being of children.
